- Completed a bench trial to a favorable verdict in Middlesex County Chancery Division, Probate Part, where he advocated for the second wife of a Decedent being sued by Decedent's two children from the first marriage, over substantial probate and non-probate assets.
- Obtained a favorable verdict after a six day bench trial in Hudson County Chancery Division, Probate Part, where he successfully defended a former executor of an Estate from claims of fiduciary breach and mismanagement.
- Has obtained numerous temporary restraining orders and preliminary injunctive relief for his clients where a fiduciary has engaged in financial improprieties or mismanagement of assets.
- Garnered a dismissal of products liability claims for a major retailer of workout equipment arising out of catastrophic injuries sustained by the Plaintiff under the doctrine of Forum Non Conveniens and failure to join an indispensable party under R. 4:6-2(f). Plaintiff appealed and Mr. Darbar prepared the opposition brief that resulted in a successful affirmation of the trial court's decision. *Nikirk v. ConducTV Brands*, No. A-1217-19T3 (App. Div. February 4, 2021).
- Served as trial counsel in November 2019 for the world's second largest manufacturer of elevators in in a multi-million dollar construction defect litigation with over fifteen defendants and obtained a favorable settlement before a jury verdict.
- Acquired a complete dismissal of Consumer Fraud, Consumer Protection, and Breach of Contract claims for a family owned and operated pool manufacturer. *Hamrahi v. Carlton Pools, Inc.*, ESX-L-8628-17 (Law Div. September 20, 2019).
